# **Strategic Priorities Outline**

- I. Expand high-quality charter options across the state of Mississippi especially in areas of high need.
  - A. Objective: Establish the Mississippi Charter School Authorizer Board as a national leader in charter school authorizing with a balanced mix of high-quality national and local operators.
    - a. Authorize additional charter schools by the end of 2016.
    - b. Identify and recruit high-quality national and local charter school operators to launch schools in future Request for Proposal cycles.
    - c. Identify two local school districts interested in charter school conversions.
    - d. Increase charter school awareness through targeted outreach activities to Mississippi communities, local school districts, and other education and business stakeholders.
  - B. Objective: Streamline the Request for Proposals process to increase accessibility and maximize transparency.
    - a. Streamline the RFP process by establishing an annual RFP timeline with two distinct application tracks for new and experienced operators.
    - b. Create an applicant toolbox that includes a variety of resources (e.g., a statewide needs analysis, an operator pitch book, and MCSAB policies).
    - c. Partner with local nonprofit organizations and universities to establish: 1) technical support during the RFP process; and 2) leadership development/application creation pipelines.
    - d. Partner with local non-profit organizations to recruit a national charter school leadership development organization to Mississippi.



# **Strategic Priorities Outline**

- II. Ensure the quality of authorized charter schools through outcomes-based accountability and oversight practices while respecting charter school autonomy.
  - A. Objective: Establish the Mississippi Charter School Authorizer Board as a national leader in charter school accountability and oversight practices.
    - a. Develop a standardized performance framework and charter contract.
    - b. Create an intervention ladder to address and resolve contract violations with charter school operators and establish a revocation protocol if violations are not addressed.
    - c. Develop an implementation plan for a charter school performance data tracking system in order to store and capture all charter school academic, financial and organizational performance data.
    - d. Establish clear expectations with charter school boards and school leaders through routine operator meetings and visits to charter school board meetings.
  - B. Objective: Develop a partnership with the Mississippi Department of Education to ensure charter schools have access to all necessary information and training.
    - a. Establish a streamlined pre-opening process with training and information sessions for authorized charter schools with MDE.
    - b. Create a communication protocol that transmits essential information from MDE and outside stakeholders to charter school leaders.



# **Strategic Priorities Outline**

- III. Establish sound organizational practices and protocols to ensure effective and transparent operation of the Mississippi Charter School Authorizer Board.
  - A. Objective: Establish fiscally-sound board practices with a focus on agency sustainability.
    - a. Establish a standing committee structure outlined in the Board's bylaws and set a routine calendar of meetings that aligns to programmatic timelines.
    - Commit to ongoing professional development on national charter authorization and highquality charter school best practices by attending conferences, school visits, and other trainings.
    - c. Secure funding, including grants and philanthropic support, to develop strong authorizing practices and attract high-quality local and national operators.
    - d. Examine the Board's budget and current contractual obligations to ensure the budget aligns to the Board's strategic priorities.
  - B. Objective: Utilize various forms of communication to promote transparency among the Authorizer Board, charter school operators, and the public.
    - a. Revise its website to further increase transparency with charter school operators and the public.
    - b. Create a user-friendly annual report provided to the public and the Mississippi Legislature.
    - c. Create an electronic pamphlet with detailed information of the laws and policies applicable to charter schools in Mississippi for the public and prospective applicants.
